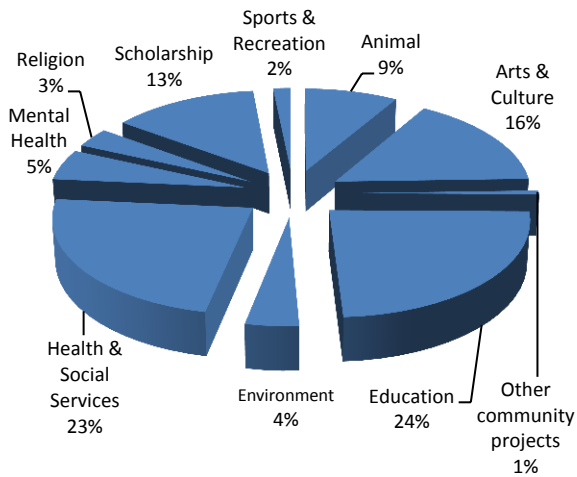

## Five Reasons People Establish a Donor Advised Fund at Coastal Community Foundation

### One

Foundation staff members provide highly **personalized services** tailored to each individual's charitable interests.

### Two

We are a **local organization** with a *thirty year history* in the community.

### Three

You have the **flexibility to invest** in causes you care about most. Donors can recommend grants to any qualified nonprofits.

### Four

Donor advisors can name **successor advisors** to their charitable fund.

Families can establish **lasting legacies** by creating permanent charitable funds in their names.



## Donor Advised Fund A Personal Approach to Giving

Establishing a Donor Advised Fund allows you to make your gift to the community foundation, and then remain actively involved in recommending uses for your gift.

You receive an immediate tax deduction in the year your fund is established.

The minimum for a donor advised fund is \$5,000. We accept a wide variety of gifts: cash, stocks and property.

You may establish a fund in your name, in the name of a loved one or be anonymous.

Grants can be made over the years in the name of your fund or you can be anonymous. Grants can support local, regional or national charities. The Foundation handles all of the administrative details.

The Foundation's professional staff can help you identify nonprofits and programs that target issues you care about most.
