Give Stock, Make a Difference, and Receive Tax Benefits



Mental Health Fund Focuses on Youth



The Mental Health Fund at Coastal Community Foundation has a 32-year history of helping to address mental health needs in the North County community, and in recent years has given special attention to programs that provide direct services to young people. The recently awarded grants support programs that directly provide prevention, early intervention mental health services, or mental health counseling to youth (21 years of age and under) in North County San Diego.

The Solana Beach Fund Supporting our Neighbors to Maintain Housing

The Solana Beach Fund's 2023 initiative aimed to assist vulnerable neighbors facing financial challenges. They raised over \$25,000 and partnered with the Community Resource Center (CRC) to aid residents of Solana Highlands Apartments in the La Colonia area. The

apartments hold historical significance as a settlement for Mexican farm workers a century ago, where some of those descendants still reside. CRC's relocation support includes financial aid for rent, deposits, and other expenses, along with transportation, food resources, utility help, storage options, and flexible relocation assistance. The goal is to ensure a smooth transition to new housing. Nearly 80 contributors supported this cause.
